Do you intend to study in Hamburg?

Start planning early! We have compiled some information to help you prepare.

Accommodation

Due to the great demand for a room in our residential complexes, waiting times are to be expected. You do not need an admission for your application! If you intend to study in Hamburg, we therefore recommend that you apply as early as possible before starting your studies. You should also note that you will be asked regularly (every 14 days) via e-mail, whether you are still interested in one of our rooms. If yes, please confirm, otherwise you will no longer be on the list of applicants.

The team of the Counselling Centre Accommodation arranges rooms in our residential complexes and provides advice on all aspects of housing. We look forward to meeting you!

BAföG

After completion of the asylum procedure, students with a refugee background can receive BAföG under certain conditions. The requirements for support for students with foreign nationality are listed in § 8 and § 61 BAföG, see „Information sheet BAföG in English (§§ 8, 61 BAföG)“ at www.stwhh.de ↪ International affairs ↪ Students from abroad.

Scholarships

There is no central office, where you can apply for a scholarship, or which forwards an application to the funding institutions. You must actively search for scholarship providers yourself and apply individually. Student loans

Loans must be repaid in full and incur additional costs due to interest. Students with a refugee background may be able to take out a government student loan after completing their asylum procedure, e.g. if you fall under the requirements of § 8 BAföG and are in the advanced study phase. In the final phase of your studies, please check whether you are eligible for a loan. Maybe you can get funding through an education fund. Good to know

Working

More than 75% of the students in Hamburg work alongside their studies. This makes working one of the most common forms of financing for students from abroad. Students with a refugee background may have a limited work permit. Regardless of this, there are other aspects to consider when working, especially when combining several activities or when not having worked in Germany before.

Our recommendation is therefore that you seek advice at our

Counselling Centre for Social & International Affairs – BeSI before you start working.

Social benefits

Under certain conditions, social benefits (housing benefit, benefits according to the German Social Code) are available for students with a refugee background especially in the event of a change of status (part-time, semester off) or in special circumstances, pregnancy/childcare, sickness/disability, etc.

Help in financial emergencies

Students of the University of Hamburg, Hamburg University of Applied Sciences, Hamburg University of Technology, Hamburg HafenCity University, Hamburg University of Fine Arts, Hamburg University of Music and Drama and Bucerius Law School, who find themselves in an unforeseen, acute, and temporary financial emergency can apply for an emergency loan or an aid respectively food vouchers for the cafeteria (Mensa) from the emergency fund of Studierendenwerk Hamburg.

Health insurance

In our information sheet „Health Insurance during studies“ (to be found at www.stwhh.de ↪ Our counselling service ↪ Counselling centre for social & international affairs). The study progress of students with a refugee background can often be delayed due to the flight, the duration of the asylum procedure and the learning of the German language.

This can lead to the fact that they cannot (any longer) be insured at the student tariff.

We therefore recommend that you seek advice from the Counselling Centre for Social & International Affairs – BeSI on the possibilities of access and extension options.
